Business Meeting Minutes**

Friday, April 14, 2006

### **APPROVAL OF MINUTES**

Mary Nemesh moved and Kay Orell seconded that the minutes from the 2005 Kansas City NASBE Business Meeting be approved as presented. The motion passed.

### **TREASURER'S REPORT**

### **ACTE/BE DIVISION UPDATE**

Mary Nemesh reported that the ACTE Convention had been moved from New Orleans to Kansas City and that Kansas City had been gracious in working with the organization to provide accommodations for the convention.

Mary recommended that members continually keep in touch with legislators concerning Perkins legislation especially before the vote is taken on reauthorization of the legislation. She extended an invitation to the ACTE Convention to be held next in Atlanta, Georgia. She announced that the President-elect position has been eliminated, and that her term is up in 2007.

### **NBEA UPDATE**

Jan Treichel, NBEA Executive Director, gave the NBEA report. She congratulated Katherine Cliatt for being awarded the Outstanding Service Award for Supervision at the awards luncheon. She announced that the next NBEA Convention would be in New York City on April 4-7, 2007. She reported that a committee is working on the third revision of the NBEA National Standards. She invited the group to encourage teachers in their states to submit ideas for the next revision of the Creative Ideas book. Cynthia Greene volunteered to represent Administration and Supervision on the NBEA Board since Angela Neal resigned. She announced that Jean Kyle will be the Program Director for Administration and Supervision for the 2008 NBEA Convention.

**NBEA PRESIDENT**

Cindy Greene, NBEA President, expressed how much she had enjoyed her visits to various parts of the country during her tenure as president, especially the opportunities she had to talk with prospective teachers. She reaffirmed her belief that NBEA is one of the best-kept secrets and encouraged everyone to get out and advertise our discipline.

**BPA UPDATE**

Marty Richards, President and CEO of Business Professionals of America, brought greetings from the National BPA Office. He announced that BPA has grown to include 24 states with over 6,000 in attendance for the National Leadership Conference in Florida. He reported that the first thing he did when he took over the organization was to have a staff retreat to promote teamwork and to work out long-range plans for the organization. **FBLA-PBL UPDATE**

Jean Buckley, President and CEO of FBLA-PBL, Inc., gave the FBLA-PBL Update. She announced that there are 626 new or reactivated chapters for this year. This has been a record year for scholarships for competitive events with six new sponsors. FBLA received a check from the Wal-Mart Corporation for \$55,000. TFI will continue to provide online testing at the NLC. Jean reported that a curriculum specialist has been hired to work with competitive events. The 2006 NLC will be in Nashville, TN.

Kara presented the Strategic Plan as a working document and moved that it be accepted with changes brought forward from the Executive Committee Meeting. The motion was seconded by Maurice. The motion passed.
